We aim to pay all supplier invoices within agreed terms whenever possible and within 60 days of invoice date as a maximum.

## LAST 6 MONTHS PERFORMANCE

94% of all invoices were paid with 60 days of invoice date, 97% were paid within 60 days of initiation by Accounts payable.

## CONTINUOUS IMPROVEMENT
