1.0 Target

We aim to pay all supplier invoices within agreed terms whenever possible and within 60 days of invoice date as a maximum.

2.0 Last 6 months performance

97% of all invoices were paid with 60 days of invoice date, 100% were paid within 60 days of initiation by accounts payable.
